

# 2016 SUMMER AID APPLICATION

## **Undergraduate Summer Session Grant:**

The summer session grant is available to all undergraduate students who are not graduating May 2016. The amount of grant awarded depends on the number of hours of enrollment and financial need (need only determines the amount of grant, not the eligibility). To be eligible, students cannot receive any other type of tuition assistance, such as employee rebate or veteran benefits. The summer session grant can only be used toward tuition.

## **Federal Loan Enrollment Requirements:**

**Undergraduate** students must be attending a minimum of 6 combined hours for the enrollment period between May 2016 and August 2016. Please note, if you choose to attend 3 hours in each session, funds will not be disbursed until Summer II enrollment of a minimum of 6 hours is verified.

**Graduate and Ph.D.** students must be enrolled for a minimum of 3 combined hours for the enrollment period between May 2016 and August 2016. Please note, if you choose to attend 2 hours in each session, funds will not be disbursed until Summer II enrollment of a minimum of 3 hours is verified.

**Law** students must be enrolled for a minimum of 2 hours for the enrollment period between May 2016 and August 2016. If enrolled for Summer II only, funds will be disbursed when Summer II begins.

## **Loan proration: Undergraduate Seniors**

If you are graduating during the Summer or Fall semester, your Federal Stafford loan eligibility will be prorated. Proration is determined by the number of hours taken in the final semester.

## **Borrower-Based Academic Year funding:**

Note: If you have borrowed your maximum Federal Stafford Loan eligibility for 2015-2016 school year, a Summer loan may reduce your 2016-2017 Federal Stafford loan eligibility. You must submit your 2016-2017 FAFSA and supporting documentation if selected for verification.

## **Necessary Steps for Federal Loans:**

The following steps must be completed before your summer loan can be processed:

- ☐ Complete 2015-2016 and 2016-2017 FAFSA (Free Application for Federal Student Aid).

- ☐ Enrolled at half-time status at St. Mary's University in a degree-seeking program.
- ☐ Have an active Master Promissory Note on file (first-time borrowers must apply online at [www.studentloans.gov](http://www.studentloans.gov) using your FAFSA pin number.)
- ☐ Loan Entrance Counseling required for first-time borrowers (visit [www.studentloans.gov](http://www.studentloans.gov) to complete Direct Loan Entrance Counseling.)
